STEP-UP 6-YEAR CERTIFICATE

Rate Information: This Account is a dividend bearing account. The prospective dividend rate on the account is 3.27% with an annual

percentage yield of 3.32%.

The dividend rate and annual percentage yield may change. At your discretion, you may change the dividend rate on the account once during the life of the certificate. You can request a dividend rate increase on your certificate, if during the life of the certificate rates increase, as determined by the credit union board of directors. Dividends begin to accrue on the business day you deposit noncash items (for example, checks). Dividends will be compounded monthly and will be credited monthly.
