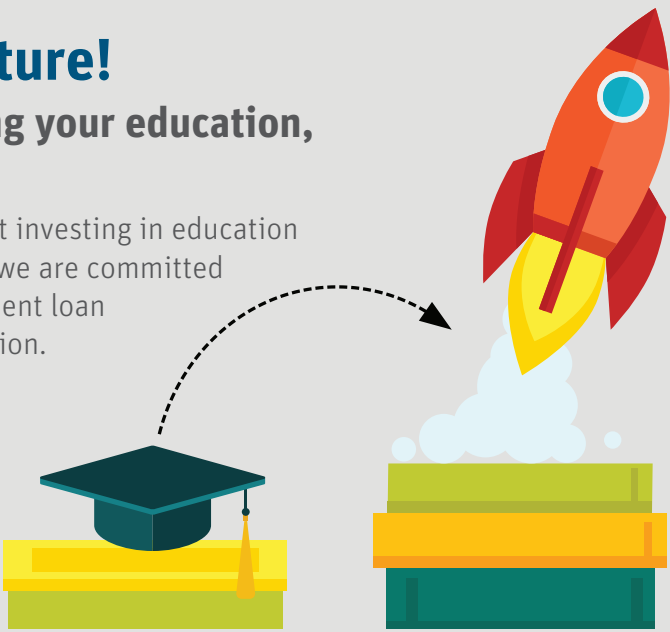




Your children should save money while having fun!
